1- According to TEQSA, academic integrity is "the expectation that teachers, students, researchers and all members of the academic community act with **honesty, trust**,

### fairness, respect and responsibility."

### Paraphrase 1:

history (1). ===) This is a form of plagiarism because the author has <u>Not</u> paraphrased the original words.

Paraphrase 2:

According to Mrak, Magical realism has a paradoxical nature that revises history and repositions social reality by recalling traumatic memories into experience ("Trauma and Memory" 1).

===) This paraphrase is valid because the author (1) gave credit to the original source, (2) paraphrased the style of the information and (3) provided the audience with the location of the information. (our focus is not whether the format of intext-citation is correct or not; The lecture focus aims to examine whether the quote contains any form of plagiarism).

### Paraphrase 3 :

Magical realism is relevant to trauma studies because of "its duality".

- ===) This is a form of plagiarism because the author has <u>NOT</u> given credit to the original source and he/she has not mentioned the location of the source.
