

How to Write an Exemplification Essay

- a. Start writing the conclusion using a transition word
- b. Summary of the main points
- c. Concluding Statement

Writing a Thesis for Your Exemplification Essay

3. How to Write an Exemplification Essay

There are several steps that need to be followed when writing an exemplification essay.

Choose your Exemplification Essay Topic

A topic should satisfy at least a single quality, including but not limited to current, specific, useful, or unique. Compose your Outline

To develop the main idea and subtopics that will represent the body paragraphs encompassing your work, it's important to organise your examples designed to strengthen the thesis statement in a local order with proper transitions for your exemplification essay outline. Although there is no holy grail for the creation of an outline for your exemplification essay, it is recommended to follow the five paragraph structure. This includes a single paragraph for the introduction, a single paragraph for the conclusion, and three paragraphs for the body.

Write the Introduction

A writer's introduction to their exemplification essay should serve three purposes, including interest, attraction, and preparation. The first sentence must immediately hook the reader. Draw the attention of readers with a rhetorical question, bold statement, or incredible statistics. The next step is to disclose background information surrounding the topic. In doing so, readers will feel confident when observing the following examples.

Create the Thesis Statement
